Please be advised that for the 2020 tax year Maple Leaf Short Duration 2019-II Flow-Through Limited Partnership (the "Partnership") will report the following capital gains:

National Class capital gain for 2020 tax year	\$18.54350 per Partnership Unit
Quebec Class capital gain for 2020 tax year	\$13.8560 per Partnership Unit

The above noted capital gains are a result of the Portfolio Manager, rebalancing the investment portfolio with a view of reducing volatility and enhancing returns while also raising the necessary cash to fund redemptions subsequent to rollover to the mutual fund. Capital gains in 2020 increase the ACB of your limited partnership units and the mutual fund shares received on rollover and therefore will reduce the capital gain when the mutual fund shares are redeemed.

Capital gains will be reported on your T5013 slip for 2020 which will be distributed directly from your dealers' back office, on or before March 31, 2021. Please note that the above is an estimate and might be slightly different on your actual tax slip.
